Draft Plan Consideration

August 17th CPRC Meeting

- CPRC sent RGM2 and RGM5/6 to P&Z
- These two items were the only outstanding items in the Plan



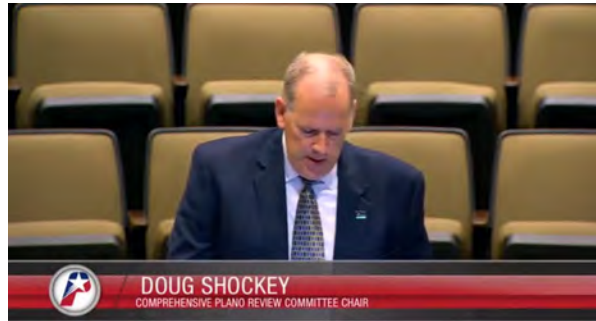
September 7th P&Z Meeting

- P&Z approved RGM5/6 (8-0) with no additional changes
- P&Z voted (8-0) to remove RGM2 from the Plan, but recommended it be presented to Council as an item outside of the Plan



September 13th Council Meeting

- CPRC and P&Z Chairs presented to Council
- Council directed staff to create a “Findings Policy” consistent with RGM1 & RGM2



September 27th Council Meeting

- Council approved a policy by ordinance consistent with RGM1 and RGM2
- CPRC's recommendation will take effect with the adoption of the Plan



Recommendation

Recommended to approve the Draft Plan as presented and move to public outreach.
